WAIVER, RELEASE AND ASSUMPTION OF RISK

In consideration of the applicant's participation in the above activity, I waive and release all claims for damages for death, personal injury or property damage that may occur as a result of engaging in that activity. This discharges in advance the Camp Shaka, its employees and other agents from liability even though that liability may arise out of their negligence. I know that this activity involves a risk of accidents, and I willingly assume the risk. This waiver, release and assumption of risk is binding on my heirs and assigns. I give permission for any medical care that the leaders of the above deem necessary.

PHOTO RELEASE

I hereby consent to the photographing, recording or reproduction in any other manner (including use of videotapes and audiotapes) of the likeness, voice and/or activities of the participant and further authorize Camp Shaka, its agents or assigns, to make unlimited use of such reproductions, including, but not limited to broadcasting to the public of the reproductions over radio and television stations. I understand that I will not receive any monetary compensation now or in the future for participating. I do hereby release and hold harmless Camp Shaka, its officers and employees, from any claims.

CANCELLATION POLICY

We do not make exceptions to this policy for any reason, including but not limited to weather or personal emergencies flight or ferry cancellations or delays. If you must cancel your reservation, our policy is as follows:

- Deposits are nontransferable and nonrefundable.
- If you cancel 15+ days prior to the first day of the session you are registered for your deposit can be utilized for another scheduled session with space available during our 2009 season.
- Payment in full is due 3 days prior to the first day of camp. Non-payment constitutes a cancellation by attendee and the reservation is canceled.
- There is no refund for arriving late or leaving early. There are no partial refunds for any services not used while at camp.
- In the event Camp Shaka must cancel a session or any portion of a session, Camp Shaka will refund your payment on a prorated scale based on the number of days canceled by Camp Shala. All refunds will be issued by bank deposit within 60 days following the cancellation which constitutes full settlement.
- Camp Shaka reserves the right to make changes to any session itinerary without notice or explanation at any time.
- Camp Shala is not responsible for expenses incurred in preparation for a canceled session.
- If you fail to provide registration information and a signed liability release waiver prior to the start of your session you will not be allowed to participate in the session and the above cancellation policy will apply. All persons attending under 18 must have the wavier signed by a parent or legal guardian with valid ID.
- All cancellations must be received in writing.

I understand and agree to the registration/refund policy herein outlined. Also, I, parent/guardian of the above named child, accept all risks incidental to camp activities and do hereby release the Camp Shaka, The Surf Sanctuary, and its officers and representatives from all liability deriving from pursuit of said activities by my child.
